#### **ETHNIC CATEGORIES:**

American Indian or Alaskan Native - a person having origins in any of the original peoples of North America and South American (including Central America), and who maintains tribal affiliation or community attachment.

<u>Asian</u> - a person having origins in any of the original peoples of the Far East, Southeast Asia, or the Indian subcontinent including, for example, Cambodia, China, India, Japan, Korea, Malaysia, Pakistan, the Phillipine Islands, Thialand, and Vietnam.

Black or Afrian American - a person having origins in any of the Black racial groups of Africa. Terms such as "Haitian" or "Negro" can be used in addition to "Black or African American".

<u>Hispanic or Latino</u> - a person of Cuban, Mexican, Puerto Rican, South or Central American, or other Spanish culture origin, regardless of race.

Native Hawaiian or Other Pacific Islander - a person having origins in any of the original peoples of Hawaii, Guam, Samoa, or other Pacific Islands.

White - persons having origins in any of the original peoples of Europe, North Africa, or the Middle East (not of Hispanic origin).

#### **DISABILITY CATEGORY:**

An "individual with disabilities" is defined as a person who: (1) has a physical or mental impairment which substantially limits one or more of his or her major life activities, (2) has a record of such impairment, or (3) is regarded as having such an impairment. For purposes of this definition, an individual with disabilities is substantially limited if he or she is likely to experience difficulty in securing, retaining, or advancing in employment because of disability.

#### **VETERAN CATEGORIES:**

A <u>"veteran of the Vietnam era"</u> is defined as a person who (1) served on active duty for a period of more than 180 days, any part of which occurred between August 5, 1964 and May 7, 1975, and was discharged or released therefrom with other than a dishonorable discharge, or (2) was discharged or released from active duty for a service-connected disability if any part of such active duty was performed between August 5, 1964 and May 7, 1975.

A <u>"special disabled veteran"</u> is defined to be a veteran who is entitled to disability compensation (or who but for the receipt of military retired pay would be entitled to compensation) under laws administered by the Veterans Administration for a disability (I) rated a 30 percent or more, or (ii) rated at 10 or 20 percent in the case of a veteran who has been determined under section 1506 to have a serious employment disability, or a person who was discharged or released from active duty because of a service-connected disability.

"Other Eligible Veterans" includes (1) veterans who served in a 'war' - veterans with active duty between December 7, 1941 and April 28, 1952 and (2) veterans who served in campaign or on an expedition for which a campaign badge, a service medal, or an expeditionary medal has been awarded.
